



FRIENDS OF LA TROBE'S COTTAGE

Dear Friends,

This is the first of a regular series of Newsletters to keep you informed of the group's activities.

The formation of the 'Friends of La Trobe's Cottage' was announced by Martin Purslow, CEO of the National Trust of Australia (Victoria) at the La Trobe Society's gathering at La Trobe's Cottage on 22 March 2009. Many members of the La Trobe Society had for some years felt that they would like to support an initiative to improve the Cottage and its contents, and we are delighted that so many La Trobe Society and National Trust members, and others, have joined the group and are already taking an active role.

The group will come under the umbrella of The C. J. La Trobe Society but report directly to the National Trust of Australia (Victoria). The aim will be to support the National Trust in its efforts to maintain the Cottage, and, through fund-raising, improve the 'Visitor Experience' at the Cottage through regular public opening times, better interpretation, and improved interior and exterior appearance.

During a meeting of the initial group at the National Trust, Tasma Terrace on 15 April, the committee of FOLTC was formed and we met on 27 April. It has been agreed that we will work through sub-committees which will each establish a programme of works. The sub-committee conveners will report to their nominated committee members, who will then report to the National Trust.

The conveners have a list of members who indicated their area of interest, and they will be forming their sub-committees. You will be hearing from them about how each group is to proceed. If you would like to be on the sub-committee of your particular area of interest, please contact your convener. Please be aware that if you would like to be involved in any activities at the Cottage – guiding, gardening, maintenance, etc., it is essential that you register as a National Trust Volunteer. Our primary task is to formulate a Master Plan, which will facilitate applications by the National Trust for grants to support us in our work to develop the interpretation of the Cottage, and to extend and maintain the cottage and garden so that it will look as it did in La Trobe's time. We will raise funds, develop an Education Program for schools, and look after the heritage aspects of the Cottage.

Many of our plans will have outcomes in the future, but we hope in the short term to initiate some immediate repairs to the building and carry out some maintenance in the garden. The Sunday openings will also be an activity to focus our attention, and that of the citizens of Victoria.

The first of our regular Sunday Openings of the Cottage is proposed for 4 October. This will follow a day of celebrations on Saturday 3 October, which is the 170th Anniversary of the official arrival of Charles Joseph La Trobe in Melbourne. We will expect the arrival of Mr and Mrs La Trobe at the Cottage at around 2pm that day. The Property Management and Gardening sub-committees will have arranged working bees before then to spruce up the building and gardens, and the current National Trust Guide group has supported the plan for these extra opening hours.

Leading up to the week-end we propose a series of information sessions when expert speakers will be invited to add to our knowledge of the Cottage.

We can all look forward with great optimism to the future. Within our ranks we have experts in their particular fields, who, along with members who have demonstrated their enthusiasm and passion, will ensure that La Trobe's Cottage, and the legacy left to Victoria by Charles Joseph La Trobe, will be preserved and treasured.

We will keep you informed about events leading up to 3 October - I look forward to seeing you all again soon.
